Communities of Opportunity addresses race and place-based inequities in health and well-being in King County by partnering with communities to shape and own the solutions for systems and policy change. Over the past six years, COO has provided more than \$40 million to community-based organizations in King County for programs and projects focused on housing, health, economic opportunity, and community connections.

Communities of Opportunity (COO) seeks to create a culture grounded in community-informed evaluation. The COO Evaluation Advisory Group (EAG) provides guidance and recommendations to COO about its evaluation, including input on approaches and methods, and supports the interpretation and dissemination of qualitative and quantitative data.

The Evaluation Advisory Group (EAG) was originally developed to support COO's baseline evaluation in 2018. Since then, the EAG has continued to support COO's data and evaluation planning and process.
